

Seven Preserve Challenge





Welcome to the ECOS Seven Preserve Challenge

Everyone loves a challenge, right? Well, not necessarily.

If the challenge is too hard, or requires too much skill, time or preparation, few are going to attempt it. That's why ECOS has chosen the hikes it has for this challenge.

We're not asking anyone to go climb all 46 Adirondack High Peaks, as is required to earn a patch and become a member of The Adirondack 46ers. Or the minimum of 23 mountains with fire towers —18 in the Adirondack Park, five in the Catskill Park —necessary to complete the Adirondack Mountain Club's Fire Tower Challenge.

This challenge can be done on flatter terrain and much closer to home, which is the whole idea. ECOS wants not only experienced hikers, but anyone, including kids, to be able to try it and succeed. We want people to be able to do it on their own, or with their families and friends, or as part of a hiking group or Scouting troop. To take as long as they want or need to do it — whether that's a few days, weeks, months, or even years. What matters is to get out there and enjoy nature, see the beauty of these local resources, learn something about their ecology and history.

Six of the preserves are in Schenectady County, while one is in Albany County.

To help you get started, ECOS offers directions, trail maps, descriptions and other information about these preserves on its website. The same can be found in paper form with our series of Natural Area Guides, which includes separate guides for Schenectady and Albany counties. ECOS also sponsors its own hikes in these preserves from time to time. You may want to check our website or Facebook page to find out when they are.

Remember: Any journey starts with that first step. So get started.

To earn your patch, you must:

1) Hike the seven preserves listed in this brochure.

2) Fill out the attached form (it is also available on our website), with your name, address, email and telephone number, the date you visited each preserve, and a sentence or two telling us about it.

3) Mail to ECOS: The Environmental Clearinghouse, 2682 Aqueduct Rd., Niskayuna, N.Y. 12309. Allow 3-5 weeks to receive your patch.
